## Foreword

This volume was compiled after several months' work — flattening, repairing, sorting, microfilming, and finally indexing Lauderdale's County's oldest documents, the Probate Files.

Many are lost, some of them probably in the courthouse fire of 18\*\*. Others undoubtedly offered irresistible temptation to history buffs or family researchers, and probably left the courthouse tucked away in a pocket or purse. But what does remain is treasure indeed.

The reader may wonder how we were able to name names in instances in which a whole file is missing. The answer is that an index was made by Works Progress Administration workers in 1931. While not completely reliable,\* the WPA Index was of immeasurable help in sorting documents that seemed to have been thrown into a pile at some point, and then stirred with a stick. A further difficulty, not an uncommon one, was the propensity of families to use the same given names in generation after generation. One or two files could not be sorted with any hope of certainty that the result would be valid.

Those interested in Lauderdale Springs are directed to the estate of Thos. Adams. The file gives tantalizing bits of information on the property that served as resort hotel, Confederate hospital, and later home to orphans of Confederate soldiers.

The facsimile reproductions come from Filebox 21 No. 186, one of several files having to do with the guardianship of minor heirs to the estate of one William Rhode(s). Taken together they offer many fascinating insights as regards the manners and mores of the day. Various witnesses were called to speak to the fitness (or otherwise) of principals in the case — an uncle, Tyree Henderson, and a grandfather, one Edgworth Pugh, in an action brought by the latter — to remove Henderson as guardian to young William and his sister Sarah, and take over the guardianship (and control of a sizeable estate) himself.

Special thanks to LCDA&H volunteer Edwin Shields for his great help in repairing the files, the detective work of sorting them, and for his long hours of microfilming, to make these precious, and fragile, documents available in a form that will leave the originals intact.

\* The WPA Index, while invaluable, does present a number of anomalies, as, for instance misreading of the ligature 'ss' as 'p.' One man with the seemingly straightforward, simple name 'John Ross' is transformed via such misreading into 'John Rop,' and in a separate entry to 'John Bop.'

## Lauderdale County, Mississippi Probate File Index

This volume holds not one but two indices. The first index, which begins on page 2, will probably prove the more generally useful. It sorts the files alphabetically according to the name of the principal or the estate, and directs the reader to the microfilm roll on which an image of each surviving document has been recorded.\*

A second index, of fiduciaries, also sorted alphabetically, lists those placed in a position of trust, i.e. executors, administrators, guardians. Petitioners were also named in this secondary index, for the sake of completeness and convenience, although they probably cannot properly be classed as fiduciaries. The second index, which begins on page 71, directs the reader to a page of this volume, where further information can be found.

It fell to the lot of some public officials to serve as administrators of estates when there was no one else available to do so. The reader will find names such as W.F. Alford, R.B.G. Harper, and Benjamin Meador followed by multiple citations (some of which refer to more than one file on a page).

Handwriting and variations in spelling presented interesting, sometimes exasperating problems — many participants in the Probate Court proceedings apparently were unable to write even their own names, and the person writing a name would have to spell it as best he or she could, so 'Herrin' may become 'Hearn,' and vice versa, 'Thames,' may go through 'Temms' to emerge as 'Tims,' and 'Hewes,' 'Hues,' and 'Hughes' may be interchangeable. No effort was made to reconcile variations in spelling.
