

PHILLIP MAGEE

SOME INFORMATION ON PHILLIP IS QUESTIONABLE. IT IS WRITTEN IN SOME MATERIAL THAT HE WAS A SOLDIER IN THE AMERICAN REVOLUTION AND LATER DREW A PENSION. HE DOES HAVE A RECORD OF SERVICE IN THE WAR OF 1812. THERE IS OR WAS A CHAPTER OF THE DAUGHTERS OF THE AMERICAN REVOLUTION NAMED FOR PHILLIP IN MAGEE, MISS. EDITH MAGEE, AN ANCESTOR WHO LIVES IN LONE STAR, WAS A MEMBER. THE BIRTH DATE WE HAVE I BELIEVE IS INCORRECT. THE YEAR 1770 WOULD MAKE HIM TOO YOUNG TO SERVE. HOWEVER, THE DAUGHTERS OF THE AMERICAN REVOLUTION PATRIOT INDEX, CENTENNIAL EDITION, PAGE 1876, INDICATES THAT PHILLIP MAGEE WAS BORN 1760-63, IN NORTH CAROLINA, AND DIED ON FEB 1, 1826, IN MISSISSIPPI. HE WAS MARRIED TO MARY BUTLER AND IS LISTED AS A SOLDIER IN NORTH CAROLINA. PERHAPS WE HAVE THE WRONG DATE OF BIRTH. INFORMATION INDICATES THAT PHILLIP IS PROBABLY BURIED AT THE OLD MAGEE CEMETERY. AFTER HIS DEATH, HIS WIFE LIVED WITH ROBERT. SHE WAS BORN AROUND 1773 AND DIED APRIL 2, 1860 AND IS PROBABLY BURIED IN THE OLD MAGEE CEMETERY. THERE WERE SIX CHILDREN FROM THIS MARRIAGE. THE INFORMATION THAT FOLLOWS COMES FROM BILL NORWOOD AND IS BLENDED WITH THE INFORMATION I HAVE ACCUMULATED THROUGH THE YEARS ON THE MAGEE FAMILY.

1. ELIZABETH MAGEE - b 1790, SAMPSON COUNTY, d DEC 2, 1865, IN RANKIN COUNTY. MARRIED WOODIE JONES JUNE 3, 1807, IN THE MISSISSIPPI TERRITORY. ONE CHILD, HIRAM A JONES WAS BORN IN 1809 AND INDICATIONS ARE THAT HE LIVED UNTIL 1832. IN 1836, ELIZABETH MARRIED WILLIAM D (OR JAMES) LEWIS WHO WAS BORN IN RANKIN COUNTY. NO OTHER INFORMATION OR BURIAL CAN BE FOUND AT THIS TIME.
2. JOHN MAGEE - b FEB 13, 1791, SAMPSON COUNTY, DIED JUNE 7, 1854, IN SCOTT COUNTY. I KNOW SOME FOLKS FROM FOREST IN THE EAST MISS. GREYS CAMP OF THE SONS OF CONFEDERATE VETERANS WHO ARE RELATED TO SOME MAGEE'S IN SCOTT COUNTY. PROBABLY THOUGH JOHN. JOHN MARRIED MARY ABBUSS IN MARION COUNTY. LATER HE MARRIED SARAH CARR (D 1849) IN 1813. THREE CHILDREN WERE FROM THIS MARRIAGE: PHILLIP MAGEE (b 1814, MARION COUNTY), JOHN L MAGEE (b MAR 22, 1819 IN SCOTT COUNTY), AND SOLOMON MAGEE (b ABOUT 1825 IN MARION COUNTY) THERE IS AN INTERESTING STORY ABOUT JOHN'S PIONEER LIFE THAT WAS PRINTED IN THE SIMPSON COUNTY NEWS ON AUGUST 8, 1946, AND REPRINTED BY THE MAGEE COURIER IN MARCH, 1991.
3. ROBERT (ROBIN) MAGEE - b FEB 14, 1793, IN DUPLIN (SAMPSON COUNTY) NORTH CAROLINA AND d NOV 11, 1859, IN COVINGTON COUNTY. MARRIED MARGARET (PEGGY) GRAVES (b JULY 19, 1795, IN LINCOLN COUNTY, GA.) ON NOV 11, 1813, IN MARION COUNTY. THIS DATE IS SIGNIFICANT BECAUSE IN 1859, THIS IS THE DATE ROBERT DIED UNDER UNUSUAL CIRCUMSTANCES. DOCUMENTS SHOW THAT ROBERT OWNED QUITE A BIT OF LAND AND SLAVES DURING HIS LIFE AND LEFT A HUGE ESTATE. HIS LAND RAN FROM AROUND PRESENT DAY SANATORIUM, MISS., TO HIGHWAY 84 AT COLLINS. THERE WAS APPROXIMATELY 25,000 ACRES. HE ALSO OPERATED VARIOUS BUSINESS VENTURES WITH SOME OF HIS SONS. THE FAMILY PLACE, OLD MAGEE CEMETERY, AND HOPEWELL PRESBYTERIAN CHURCH ARE IN THE SAME GENERAL AREA,

LOCATED AROUND OLD DRY CREEK BOTTOM. THIS CREEK RUNS ACROSS SOME PASTURE LAND MY GRANDFATHER OWNED. IT SELDOM HAS WATER FLOWING UNLESS IT RAINS. MY FATHER REMEMBERS THE CREEK BANKS BEING DUG AND CHANNLED WHEN HE WAS SMALL. THIS LAND IS NOW OWNED BY LOIS CALHOUN, MY AUNT. THERE IS QUITE A CONTROVERSY SURROUNDING THE RELATIONSHIP BETWEEN ROBERT AND ELIZA GRAVES, HIS WIFE'S YOUNGER SISTER. IT IS INDICATED THAT SHE DIED IN 1892. MORE INFORMATION ON HER IS PRESENT IN THIS PAPER. THERE WAS A CHILD, SUSANNAH GRAVES MAGEE, BORN OF THIS RELATIONSHIP IN 1833. ROBERT HAD A VERY INTERESTING LIFE. I HAVE ALSO SEEN RECORDS OF LAND HE OWNED AROUND GREENSBURG, LOUISIANA. HE ALSO DEEDED THE LAND TO HOPEWELL PRESBYTERIAN CHURCH FOR THE BUILDING. ROBERT DIED ON NOVEMBER 11, 1859, WHILE VISITING A LADY FRIEND AT ANOTHER FRIEND'S HOME. LOOK AT THE MAGEE FAMILY HISTORY ELSEWHERE IN THIS BOOK, IT MAKES INTERESTING READING

4. SOLOMON MAGEE - b JAN 29, 1795, SAMPSON COUNTY, NORTH CAROLINA AND d AUG 18, 1826 IN SIMPSON COUNTY, MISS. MARRIED ELIZABETH WEATHERSBY (b MAR 28, 1798 IN BLADEN COUNTY, N.C.) ON NOV 24, 1814, IN MARION COUNTY. SHE DIED MAR 24, 1858, AND BURIED IN THE WALKER CEMETERY IN SIMPSON COUNTY. THERE WERE FIVE CHILDREN OF THIS MARRIAGE. A GRANDSON, **ROBERT SOLOMON MAGEE (CSA)**, SERVED IN CO. B, 16TH MISS. ONE RECORD SHOWS HE WAS DISCHARGED ON SEPT 30, 1862, AS BEING UNDER 18 YEARS OLD. HE WAS BORN MAR 2, 1845, AND DIED AUG 18, 1888, THE RESULT OF A BUGGY ACCIDENT. INFORMATION IS THAT HE WAS THE FIRST POSTMASTER OF A TOWN NAMED AFTER HIM, MAGEE, MISS. HE IS BURIED IN THE MAGEE FAMILY CEMETERY, 2 MILES NW OF MAGEE, MISS.

5. CATHERINE (KITSEY) MAGEE - b JAN 31, 1797, IN SAMPSON COUNTY. d 1852 IN MISSISSIPPI. MARRIED HENRY TOLER ON DEC 1, 1812, IN MARION COUNTY. TWO CHILDREN BORN.

6. BERSHEBA MAGEE - b JAN 12, 1800, SAMPSON COUNTY. d FEB 29, 1876, IN SIMPSON COUNTY, MISS. BURIED IN THE FRANCIS MARION WALKER CEMETERY, SIMPSON COUNTY. MARRIED RICHARD TULLOS ON FEB 19, 1816, IN MARION COUNTY. FIVE CHILDREN. ABOUT 1830, SHE MARRIED JACOB GRUBER (GRUBBS) WHO WAS BORN JULY 3, 1812 AND DIED SEPT 23, 1880. ONE CHILD, ROSENA, WAS BORN ON JAN 29, 1839. GRUBER IS BURIED IN THE FRANCIS MARION WALKER CEMETERY. ROSENA MARRIED **GEORGE WASHINGTON WALKER (CSA)** (b JAN 22, 1834 IN SIMPSON COUNTY AND DIED NOV 9, 1882) ALSO BURIED IN THE FRANCIS MARION WALKER CEMETERY. I BELIEVE THAT GEORGE WASHINGTON WAS IN THE CONFEDERATE ARMY, CO. H, 6TH MISS. INFANTRY. THERE IS A LISTING OF 1ST SGT G W WALKER ON THE SIMPSON COUNTY CONFEDERATES WEBSITE. WILL SECURE HIS SERVICE RECORD ON MY NEXT TRIP TO JACKSON. THIS COMPANY WAS FORMED IN SIMPSON COUNTY AS THE SIMPSON FENCIBLES, THE SAME COMPANY THAT WARREN G MAGEE WAS IN BEFORE HE BECAME ILL IN KENTUCKY AND RETURNED HOME IN EARLY 1862. THE 6TH MISS., KNOWN AS THE "BLOODY SIXTH", WAS IN HEAVY ACTION AT SHILOH AND LOST QUITE A FEW MEN. THE MAGEE HISTORY STATES THAT WARREN WAS THERE, BUT THAT'S NOT TRUE. IF GEORGE WASHINGTON WAS THERE, HE HAD QUITE A STORY TO TELL.

MARY ANN MAGEE-b JUL 15, 1815 (MARION COUNTY) D-JAN 9, 1899 (ATTALA CO.) MARRIED WILLIAM STANHOPE ROSS ON NOV 29, 1829. HE WAS A PROBATE JUDGE AND FARMER. ONE RECORD INDICATES BURIAL IN KOSCIUSKO CEMETERY. HAD 13 CHILDREN, AT LEAST THREE FOUGHT IN CO. I, 13TH MISS, ONE WOUNDED BADLY, ONE DIED OF WOUNDS, AND ONE RETURNED HOME UNHARMED.

SARAH ANN MAGEE-b AUG 14, 1816, (LAWRENCE COUNTY, MISS) d DEC 5, 1901 AND BURIED IN FRANCIS MARION WALKER CEMETERY IN SIMPSON COUNTY, MISS. MARRIED OWEN WEATHERSBY JAN 30, 1833. HE IS BURIED IN THE SAME CEMETERY. SARAH ANN WAS THE SECOND BORN BUT THE LAST CHILD OF ROBERT MAGEE TO CROSS OVER THE RIVER.

1. MARY ANN WEATHERSBY b MAR 30, 1834 d OCT 9, 1835 (BURIED IN CEMETERY NEAR MT ZION CHURCH IN SIMPSON COUNTY)

ELIZABETH CAROLINE MAGEE-b NOV 22, 1817 (LAWRENCE COUNTY, MISS) d 1843 (SIMPSON COUNTY, MISS) ONE FAMILY STORY STATES THAT ELIZABETH CAROLINE WAS THE CHILD OF ROBERT AND ELIZA GRAVES (MARGARET GRAVES' SISTER). DO NOT BELIEVE THIS TO BE TRUE. SEE INFORMATION ON SUSANNAH GRAVES MAGEE IN THIS SECTION. CAROLINE MARRIED MICHAEL DURR WHO WAS BORN IN SOUTH CAROLINA, SEPT 6, 1810, AND DIED FEB 1, 1876. MICHAEL IS BURIED IN THE OLD MAGEE CEMETERY ON THE JAYNESVILLE ROAD. HE WAS A CLERK IN A STORE OWNED BY ROBERT MAGEE. AFTER THE DEATH OF CAROLINE, MICHAEL MARRIED ELIZA GRAVES IN 1844. THIS COULD CAST SOME DOUBT THAT CAROLINE WAS THE CHILD OF ROBERT AND ELIZA. FOUR CHILDREN WERE BORN OF THIS MARRIAGE AND ALL FOUR HAD CLOSE CONNECTIONS TO THE CONFEDERATE ARMY. MICHAEL DURR WAS QUITE WEALTHY. IN 1870, AFTER THE DEVASTATING WAR YEARS, MICHAEL LISTED \$1400 IN REAL ESTATE VALUES AND \$900 IN PERSONNEL PROPERTY. IN 1850, HE OWNED 39 SLAVES AND IN THE 1860 CENSUS, HE OWNED 62 SLAVES.

(BURIED IN THE MILSAPS aka OLD PLEASANT VALLEY CEMETERY IN COPIAH COUNTY, MISS) LISTED AS R J DURR, MD. MARRIED MARY MILSAPS ON FEB 19, 1868. ROBERT ORGANIZED CO A, 39TH MISS AT WESTVILLE. LATER HE BECAME THE 39TH'S COMMANDER AND SEAR'S BRIGADE COMMANDER IN DEC, 1864. HE WAS A BRAVE AND RESOURCEFUL OFFICER, ENDING THE WAR AS A MAJOR. HE IS MENTIONED IN ORDERS FOR SERVICE.

2. ELIZABETH CAROLINE DURR b JULY 11, 1838 (SIMPSON COUNTY, MISS) d 1875 (SIMPSON COUNTY, MISS) MARRIED JAMES J LOCKHART (CSA) WHO WAS A PVT IN Co A, 24TH BATTALION MISSISSIPPI CVALRY. ONE CHILD WAS BORN AND DIED ON SEPT 1, 1869, UN-NAMED. THE CHILD IS LISTED AS BEING BURIED IN THE OLD MAGEE CEMETERY.

3. EMANUEL ALEXANDER DURR (CSA)- b MAR 11, 1840 (SIMPSON COUNTY, MISS) d 1879 IN GEORGETOWN (COPIAH COUNTY) MARRIED EMMA BRENT. TWO CHILDREN, BRENT AND CARRIE (NO DATES) CARRIE MARRIED EDDIE WALKER AND BRENT HAS NO WIFE LISTED. EMANUEL SERVED IN Co A, 39TH MISS AND Co B, 4TH MISS CAVALRY. HAVE NOT LOCATED BURIAL PLACE, THERE ARE TO UN-CENSUSED CEMETERIES AROUND GEORGETOWN.

4. MARY ANN DURR b APR 1, 1842 (SIMPSON COUNTY, MISS) d APR 1, 1915 (COPIAH COUNTY, MISS) MARRIED ON DEC 18, 1862, TO ROBERT PATTON WILLING (CSA) b JUNE 21, 1835 d MAY 7, 1905 (COPIAH COUNTY, MISS) BURIED IN HAZELHURST CEMETERY. ROBERT WAS A LEUTENANT Co D, 12TH MISS.

AMANDA ELEANOR MAGEE-b MAY 26, 1820 (COVINGTON COUNTY, MISS) d APRIL, 1897 (COVINGTON COUNTY, MISS) BURIED IN THE FRONT PART OF SALEM BAPTIST CHURCH CEMETERY, UNMARKED, CLOSE TO DAUGHTER ELLEN ROGERS. MARRIED ISAAH NORWOOD, b 1812, DARLINGTON, SOUTH CAROLINA. HE DIED IN DECEMBER, 1887 (COVINGTON COUNTY, MISS) AND IS PROBABLY BURIED IN AN UNMARKED GRAVE AT THE OLD MAGEE CEMETERY. A RESEARCHER INDICATES THAT THE FAMILY WAS QUITE POOR AT THE TIME, THEY HAD LOST ALL THEIR PROPERTY AND WEALTH. ORIGINALLY, ISAAH AND AMANDA LIVED IN THE LEAF RIVER COMMUNITY AND WERE LIVING WITH RELATIVES. THIRTEEN CHILDREN WERE BORN OF THIS MARRIAGE.

1. MARGARET NORWOOD- b FEB 15, 1837(SIMPSON COUNTY, MISS) d FEB 10, 1872 (BURIED UNMARKED MT ZION BAPTIST CHURCH CEMETERY, MENDENHALL) MARRIED WILLIAM BARNES (CSA) b 1834. WHO IS LISTED AS A PVT IN Co B, 4TH MISS CAVALRY. BARNES REMARRIED AFTER MARGARET'S DEATH.

2. KATHERINE NORWOOD- b MAY 16, 1838 (SIMPSON COUNTY, MISS) d MAY 11, 1921 (SIMPSON COUNTY, MISS) BURIED IN MAGEE CEMETERY, MAGEE. MARRIED JERRY ROGERS AND THEN JOHN "JERRY" RYAN WHO WAS BORN IN IRELAND ABOUT 1837. RYAN IS ALSO BURIED IN THE MAGEE CEMETERY.

3. MARY JANE NORWOOD-b 1840 (COVINGTON COUNTY, MISS) d 1860 MARRIED JESSE B LOTT. ONE CHILD, ISAUQUENA, WHO MARRIED ROY GRANT LOGAN.

4. JOHN JEFFERSON NORWOOD (CSA)- b 1842 (COVINGTON COUNTY, MISS) d IN 1865 DURING THE WAR BETWEEN THE STATES. ONE LISTING FOR JOHN J NORWOOD IS Co B, 16TH MISS (WESTVILLE GUARDS) RAISED IN SIMPSON COUNTY.

5. ROBERT NORWOOD (CSA)- b AUG 1, 1844 (JAYNESVILLE, COVINGTON COUNTY) d JUNE 6, 1914, BURIED IN SALEM BAPTIST CHURCH CEMETERY, SERVED IN Co B, 4TH MISS CAVALRY, DISCHARGED WITH GENERAL FORREST'S COMMAND AT GAINESVILLE, ALABAMA, ON MAY 14, 1865. MARRIED THE WIDOW OF CAPTAIN WARREN G MAGEE, MARTHA WEATHERSBY MAGEE, HIS AUNT. THEY HAD SEVEN CHILDREN. SHE DIED NOV 4, 1893

AND IS BURIED IN OAKVALE CEMETERY. ROBERT THEN MARRIED JOANN DUCKWORTH WHO WAS BORN DEC 14, 1862, IN COLLINS, MISS. ROBERT WAS THE FATHER OF SIX CHILDREN BY THIS MARRIAGE. JOANN DIED FEB 2, 1952 IN RICHTON, MISS, WHERE SHE RAN A HOTEL. SHE IS BURIED IN THE SUNSET CEMETERY IN RICHTON WITH HER DAUGHTER, CLARA MAE. JOANN WAS THE DAUGHTER OF CAPTAIN JOSEPH T DUCKWORTH (CSA), ENLISTED BY MAJOR T D MAGEE AT WILLIAMSBURG IN Co B, 6TH BATTALION, WHICH LATER BECAME THE 46TH MISS. CAPTAIN DUCKWORTH IS BURIED AT THE SALEM BAPTIST CHURCH CEMETERY IN COVINGTON COUNTY. CAPTAIN DUCKWORTH WAS THE ONLY MEMBER OF Co. B, 46TH MISS. TO REACH THE UNION TRENCHES AT FRANKLIN, TENN. ON NOVEMBER 30, 1864. HE WAS CAPTURED AT NASHVILLE ON DECEMBER 15, 1864, AND WENT TO A UNION PRISON CAMP UNTIL THE END OF THE WAR.

6. LAURIN MAGEE NORWOOD- b 1847 (COVINGTON COUNTY, MISS) d BEFORE 1860 CENSUS SINCE HE IS NOT LISTED. APPEARS TO BE NAME FOR LAURIN R MAGEE, AN UNCLE.

7. SUSANNA NORWOOD- b 1848 (COVINGTON COUNTY, MISS) MARRIED JOSEPH EVANS, NO CHILDREN. d 1918 (COVINGTON COUNTY, MISS)

8. JACKSON NORWOOD- b 1851 (COVINGTON COUNTY, MISS) NO OTHER INFORMATION

9. CAROLINE VIRGINIA NORWOOD- b JAN 9, 1853 (COVINGTON COUNTY, MISS) d JAN 24, 1891, AND BURIED IN NORVEL ROGERS CEMETERY IN COVINGTON COUNTY, MISS. MARRIED BENJAMIN LUTHER ROGERS, HAD SIX CHILDREN. HE DIED JAN 20, 1930 AND IS BURIED IN THE MT OLIVE CEMETERY.

10. MARTHA L NORWOOD- b DEC 2, 1854 (COVINGTON COUNTY) d JULY 25, 1935 AND BURIED IN THE LEAF RIVER CEMETERY. MARRIED LUTHER TERRELL SPEED IN 1880. NINE CHILDREN CAME FROM THIS MARRIAGE. HE DIED SEPT 25, 1917, AND BURIED IN THE LEAF RIVER CEMETERY.

11. FLORENCE L NORWOOD- b ABOUT 1856 (COVINGTON COUNTY) NEVER MARRIED, A MEMBER OF HOPEWELL PRESBYTERIAN CHURCH. DIED AT AN EARLY AGE.

12. AMANDA ELEANOR (ELLEN) NORWOOD- b AUG 1858 (COVINGTON COUNTY) d OCT 1918 AND BURIED IN SALEM BAPTIST CHURCH CEMETERY. A MEMBER OF HOPEWELL PRESBYTERIAN CHURCH SEPT 1878. MARRIED NORVEL MARION ROGERS b JAN 26, 1857 (COVINGTON COUNTY) d JAN 1949 AND BURIED AT SALEM BAPTIST CHURCH CEMETERY. TWELVE CHILDREN CAME FROM THIS MARRIAGE.

13. ISAIAH (ZADIE) M NORWOOD- b 1863 (COVINGTON COUNTY) d SEPT 9, 1932, IN GULFPORT, BURIED IN ALLEN CEMETERY. SOMETIMES NIGHT POLICEMAN AND NIGHT MARSHALL OF COLLINS. MARRIED BETTY COOKE SIMS AND HAD FIVE CHILDREN. MARRIED NETTIE PITTS IN 1896, COVINGTON COUNTY. NO CHILDREN FROM THIS MARRIAGE.

TURPIN DICKSON MAGEE (CSA)- b FEB 1, 1824 (COVINGTON COUNTY) d MAR 13, 1879 (COVINGTON COUNTY) BURIED IN MAGEE CEMETERY ON JAYNESVILLE ROAD. MARRIED MATILDA CAROLINE WHITE ON JAN 11, 1844. SHE WAS BORN DEC 18, 1825 AND DIED MAR 24, 1881. DICKSON IS BURIED IN THE OLD MAGEE CEMETERY ON THE JAYNESVILLE ROAD. CAROLINE WAS BURIED IN THE FRONT YARD OF THEIR HOME IN THE FRIENDSHIP COMMUNITY ON HIGHWAY 84. WHEN THE HIGHWAY WAS WIDENED IN 1999, THE REMAINS AND STONE WERE MOVED BESIDE DICKSON IN THE OLD MAGEE CEMETERY. DICKSON RAISED Co B, 6TH MISS BATTALION IN WILLIAMSBURG IN FEB, 1862. HE WAS CAPTAIN OF Co B, LATER RAISED TO A FIELD AND STAFF POSITION AS A MAJOR. HE FOUGHT IN THE VICKSBURG CAMPAIGN, ACROSS MISSISSIPPI, AND ALABAMA, AND IN THE

GEORGIA CAMPAIGN. WHEN COLONEL CLARK WAS KILLED AT ATLANTA, DICKSON WAS PROMOTED TO COMMAND OF THE 46TH MISSISSIPPI REGIMENT AND LED THE REGIMENT THROUGH THE BATTLE OF FRANKLIN. HE WAS WOUNDED THERE AND ONE SOURCE INDICATED THAT HE WAS CAPTURED IN DECEMBER, 1864, WHEN THE UNION ARMY DROVE THE ARMY OF TENNESSEE FROM NASHVILLE. HIS RECORD DOES NOT INDICATE HIS CAPTURE BUT IT IS POSSIBLE. I HAVE VISITED THE FRANKLIN BATTLE SITE (THERE IS NO BATTLEFIELD LEFT) AND A GUIDE FROM THE CARTER HOUSE TOOK ME TO WHERE THE 46TH MISS STRUCK THE UNION LINES. DICKSON WAS WOUNDED JUST BEFORE THE TRENCHES WERE REACHED. I WAS IN THE GENERAL VICINITY OF WHERE HE FELL. HOWEVER, THERE ARE HOUSES AND YARDS THERE NOW. LEFT A COPY OF HIS PICTURE AT THE CARTER HOUSE ALONG WITH INFORMATION ABOUT HIM AND THE MAGEE FAMILY. HE AND CAROLINE HAD FIVE CHILDREN.

1. ALEXANDER GRANT ROSS: MUSTER ROLL SHOWS 17 YEARS OLD IN 1861. HE WAS BADLY WOUNDED AND CAPTURED AT THE BATTLE OF CEDAR CREEK IN 1864. HE WAS ADMITTED TO THE US HOSPITAL IN BALTIMORE ON JANUARY 14, 1865, WHERE HIS LEG OR ARM WAS AMPUTATED, POSSIBLY BOTH, THE DOCUMENTS ARE NOT CLEAR. ON JANUARY 18, 1865, HE WAS ADMITTED TO THE U S HOSPITAL AT FREDERICK, MARYLAND. FROM THERE HE WAS TRANSFERRED TO FORT McHENRY AND THEN ON TO POINT LOOKOUT FOR EXCHANGE. IN MARCH, 1865, HE FILED PAPERS TO BE DISCHARGED AND RETIRED BECAUSE OF HIS WOUNDS. THIS DOCUMENT SHOWS HIS AGE TO BE 20, SIX FEET TALL, FAIR COMPLEXTION, DARK HAIR AND EYES, AND A FARMER. IT IS PRESUMED THAT HE WAS IN THE CHARGE AT GETTYSBURG ON JULY 2, 1863.

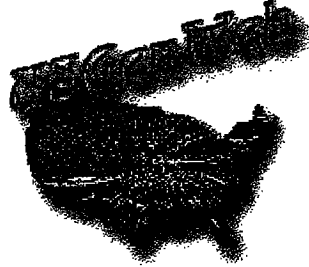
2. FRANCIS (FRANK) M ROSS: MUSTERED WITH COMPANY I, 13TH MISSISSIPPI, AT KOSCIUSKO MARCH 15, 1861. ONE RECORD SHOWS HIM TO BE 26 YEARS OLD. HE IS DESCRIBED AS 30 YEARS OLD, SIX FOOT TWO INCHES TALL, BLACK EYES AND HAIR, AND DARK COMPLEXTION. IT IS PRESUMED THAT HE ALSO WAS AT GETTYSBURG.

3. WILLIAM D ROSS: SHOWN AS 18 YEARS OLD. MUSTERED IN KOSCIUSKO AND ENROLLED AT CORINTH IN MAY, 1861. SHOWN AS SIX FOOT ONE INCH TALL. IN MAY, 1864, HE IS LISTED IN THE GENERAL HOSPITAL, PARKER'S STORE, SPOTSYLVANIA, VIRGINIA. HE WAS WOUNDED AT THE BATTLE OF THE WILDERNESS AND DIED OF WOUNDS AT THE GENERAL HOSPITAL MAY 6, 1864. HE RESTS AT THE FREDERICKSBURG CIVIL WAR CEMETERY IN VIRGINIA. SEE LISTING FOR INFORMATION. IT IS ALSO PRESUMED THAT HE WAS IN THE CHARGE AT GETTYSBURG.

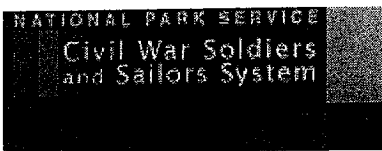

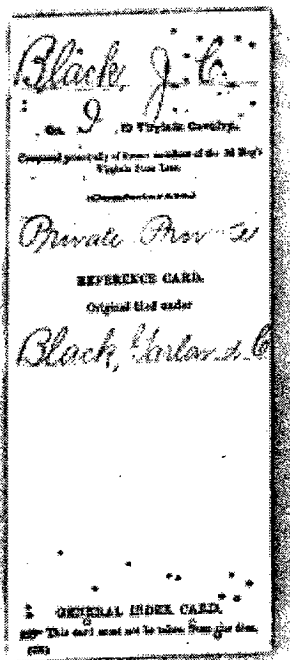
