

ABSALOM W. GALLESPIE

Absolom W. Gallepie was born in Tennessee about 1804. He came to Alabama where he married Sarah Mott on March 1, 1829, in Marengo County. Sarah, born about 1811, was the second child of Capt. Lovelace Mott and his wife, Nancy. (Capt. Mott fought in the 1813 Creek Indian Wars in Alabama before moving the Mott family to Lauderdale Co., Miss.)

Absolom and Sarah moved to the wilderness in Lauderdale County, Mississippi about 1835, soon after the new county was formed. [Lauderdale Co. was formed in 1833 from the 1830 Mississippi Choctaw Land purchase.] The Gallepies did well in Mississippi; the 1858 Lauderdale Co. tax roll shows them owning 600 adjoining acres of land as follows; Sec. 13, Township 7, Range 15E (120 Ac), S-18,T-7,R-16E (360 Ac), and S-19, T-7, R-16E (120 Ac). (This land is near the city limit north of today's Meridian.) They owned one slave when they came, but in later years they owned five.

It is interesting to note that Capt. Lovelace Mott, Sarah Gallepie's father, owned 120 acres of land adjacent to, and west of, Gallepie according to the 1841 tax roll. The Mott land was in Sec. 12 and 13 of T-7, R-15E. Capt. Mott died in 1846 and his estate was probated in Lauderdale Co.

The first three of Absolom and Sarah's children were born in Alabama but they had six more born in Lauderdale County. Sarah died around 1858 in Lauderdale County.

After Sarah's death, Absolom married Frances E. Harper, although the location of this second marriage has not been determined. His second marriage produced one child, Susan A., born in 1860.

In August 1865, Absolom and Frances Gillespie were received by experience in Fellowship Baptist Church, located north of Pine Springs community near Rushing Store. The following March, Bro. Oliver Brown reported he had seen Bro. Gillespie under the influence of liquor - this was backed up by a statement from Bro. Knox. After some explanation, Bro. Gillespie was forgiven by the church.

During reconstruction after the Civil War, Absolom apparently turned more to alcohol; in December 1867, it was reported that Bro. Gallepie was in the habit of drinking to excess. A committee was assigned to meet with Bro. Gillespie and to report back to the church. After some explanation in March (1868), Bro. A.W.Gillespie gave a satisfactory report to the church. However, came July, he was again charged with drinking to excess and profane swearing but, again, was forgiven.

During the times of hardship and actual hunger following the war, the Gallepies left for Texas. Perhaps they thought that there, where battles had not been fought, they could start over. In November, 1868, Absolom and Frances requested and received letters of dismissal from

Fellowship Church.

On December 6, 1868, Absolon sold John McDonald (son of James B. McDonald) 80 acres in S-7, T-7, R-16, for \$300.

On the same date, he sold 600 acres, the balance of his plantation, to R.N. ~~and Louisiana~~ Gunn. They left ~~for Texas~~ about this time *FOR VERMILION PARISH, LOUISIANA.*

Married: (1) John Perry, Jr., son of John and Mary Freeman Perry, in 1849. (2) Samuel T. Hatcher, second child of Samuel C. and Sarah (Head) Hatcher's four children, in 1859.

Susanah, sometimes called Susan, was a native of Alabama. When she was about five, her family moved to Lauderdale County, Mississippi where Susanah grew up. When she was about 16 (in 1846?) she married John Perry, son of the late John Perry and Mary Freeman Perry. (Mary Freeman Perry's sister was married to George Gallepie, a relative of Susanah's.)

John and Susanah Perry bought (leased?) 120 acres of land in the northeast quarter of Sec-16, T-7, R-16E, in what was later to be called the Pine Springs community (northeast of today's Meridian) from William and Martha Brown Hamrick. They, and their infant daughter, Sarah Marie, moved to this land in December 1847. It was excellent cotton land. Rogers Creek ran the half mile length of the place on the east side. John was industrious and made the rich creek bottom produce.

The Perry's had three more children born in 'Pine Springs' before he died, a young father. Apparently John knew his death was imminent and wrote a will on his death-bed on April 11, 1853. The three witnesses to his will were Susanah's uncle, Absolom Mott, E.J.Chatham, and neighbor James B. McDonald. He died a week later on April 11. His estate was probated in Lauderdale County Probate Court.
