GENEALOGY OF THE PIGFORD FAMILY

INTRODUCTORY

Sometime between the years of 1735 and 1745, on the coast of North Carolina, a small lad was picked up from the wreck of a ship lost at sea. He could tell only that his name was Billie Pigford and that he, with his parents, had sailed from England. (Incidentally, my brother Russell Pigford, searched in England and Scotland for the name of Pigford and found only the name of Pickford, therefore, our name may rightfully be Pickford.) This boy, Billie, was taken into a Dutch family with whom he lived until he grew to manhood. He was always called "Lost Billie". He married a woman of Dutch descent. They reared a family of five sons, viz: William, Solomon, Jacob, Ned and Timothy, and one daughter, Patsy.

LINEAGE OF TIMOTHY PIGFORD (The Writer's Direct Line)

Timothy Pigford married Elizabeth Wells who was of Scotch descent. Their children: Wright, William Wells, Alfred, Timothy, and daughters Sara, Patsy, Elizabeth and Jerusha. The family lived in North Carolina until the husband and father died. The widow with her children then moved to Alabama, then Mississippi.

The family moved from Toomsuba to Lockhart, Mississippi, in 1857. William Wells was a successful merchant and farmer. He died, however, while the South was in the throes of the Civil War in 1863. Though he had considerable property, it was nearly all wiped out by the ravages of war and the passing through of Sherman's Army just after his death. The widow, with her brood of ten children, was left practically penniless. Immediately after the war, her two oldest sons who had just attained the age of manhood, died and the family was then deprived of their bread earning capacity. On a small farm which she possessed, she struggled along, tilling the land while the children went to school at intervals. Charles Alfred, the writer's father, was the oldest son, at that time being eight years of age. When he attained the age of twenty, despairing of survival from the soil, he determined to try railroading. Although the work might be more strenuous, pay day would come more frequently.
