

THE HODGES FAMILY

The Hodges family came from Georgia and were among the early settlers of Sumter County, Alabama. Robert Hodges died in Sumter County in 1844, leaving a will. He did not name his wife in his will, so we assume that she was already deceased. Robert did mention three of his children; his sons James and Allen Hodges and his daughter, Mrs. Cely Hodges Hillson. Robert also left small bequests to the following grandchildren: Amos Hodges, (who acted as administrator of Robert's estate after Robert's son James moved out of state. Amos later moved to Lauderdale County.)

AMOS HODGES

Amos Hodges, a grandson of Robert Hodges, was born in Georgia in 1810 and came to Alabama with the Hodges family when he was a young man. Apparently he was a son of either James or Allen Hodges, but we know not which.

Amos married Miss Nancy Jane Radford in Chatham, Alabama about 1845 and they had four children when they moved to Lauderdale County, Mississippi. Amos bought land in Sections 1 and 2 of Township 8, Range 14E in Lauderdale County, which was in the southwestern part of the county between Meehan and Arundal. He and Nancy Jane had three more children born in Lauderdale County before the Civil War came, AND he bought more adjoining land.

When the war started, Amos Hodges enlisted in the Confederate Army where he died in 1862. His estate was probated in Lauderdale County and his brother, James A. Hodges, was appointed administrator by the probate court. Nancy was appointed guardian of their minor children.

James A. Hodges was living in the northern part of the county near Hickory Grove Church, and it appears that Nancy and the children ^{LIVED} moved near him following the war. On April 26, 1865, Nancy Jane married Edward King.

JOHN WESLEY HODGES

The son of Amos and Nancy Jane (Radford) Hodges, John Wesley Hodges was born in Choctaw County, Alabama on the 5th of November in 1854. He was very small when his father bought land in Mississippi and moved the family there.

John's father fought with the Confederate Army in the Civil War and died in the war in 1862. John was then about seven years old. It is thought that the family then moved to the northern part of Lauderdale County, perhaps to lived near John's uncle, James A. Hodges. In 1865 John's mother married Edward King. John lived with his mother and step-father near Lizelia during the reconstruction period following the war.

John W. Hodges was married the first time to Mary Etta _____, (b 1857). She died in 1892 and John then married Miss Della Ethridge who lived near the Martin community. Della died in 1900 and John was married for the third time to Miss Mary Jane Moore (b.1879) who everyone called Macie. She was a talented, beautiful girl, the daughter of Walter and Carolyn (Barber) Moore who lived near Collinsville. She had dark red hair and was an accomplished pianist.

John W. Hodges died on March 16, 1912 and was buried at Pine Grove Baptist Church near his home in Martin. Macie died Oct. 10, 1929.
